## SUMMARY ANNUAL REPORT FOR UNITED FOOD AND COMMERCIAL WORKERS UNIONS AND EMPLOYERS MIDWEST HEALTH BENEFITS FUND

This is a summary of the annual report for United Food and Commercial Workers Unions and Employers Midwest Health Benefits Fund, EIN 36-6598490, for the year ended November 30, 2021. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### Insurance Information

The plan has contracts with Dearborn Life Insurance Company to pay group life and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the policy year ending November 30, 2021 were \$61,236.

### Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan was \$13,030,275 as of November 30, 2021 compared to \$11,039,889 as of December 1, 2020. During the plan year, the plan experienced an increase in net assets of \$1,990,386. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$19,828,428 including (but not limited to) employer contributions of \$16,302,443, participant contributions of \$124,633, gain from the sales of assets of \$151,144 and income from investments of \$695,336.

Plan expenses were \$17,838,042. These expenses included \$16,169,414 in benefits paid to participants and beneficiaries and \$1,668,628 in administrative expenses.
